PRIVACY POLICY

1.) **Transmission of personal financial information of donors.**

Resident Bolde recognizes the importance of maintaining private and secure financial transactions of its donors.

In the event that Resident Bolde starts accepting donations via credit card, end to end encrypted payment processors will be provided. Those third party tools will store clients' information in their secure platforms. Breaches in security can still happen and patient will accept this risk also. Resident Bolde will not independently transmit or store credit card information through its web interface.

Mailing checks as a form of donation will also be accepted. Mailing checks is reasonably secure as the data is not transmitted to multiple servers over the internet. A tracking and signature is required to confirm receipt. If for any reason a check is lost in transit a stop order should be placed with your bank.

Donors personal or financial information will not be shared with third parties. Basic identification information such as first and last name, phone number, email address will be stored to be able to keep in touch with the donor. Identification such as social security, passport numbers, drivers license, birth certificates etc. will never be asked of any visitor or donor by Resident Bolde. If in the event that ever were to happen, please contact residentbolde@gmail.com immediately and contact your credit reporting agencies to place a freeze. Never respond to such inquiries with such personal data.

Even though every effort is made to protect privacy of sensitive information, no internet based communication or transaction is a 100% secure. By doing any type of internet based transaction you are accepting that risk.

2.) **Legal Referrals**

Discussion of potential legal cases with an attorneys will only happen at the specific written request by a medical resident. Otherwise no information will be shared about a resident's particular circumstance regarding their residency program.

3.) **There are legal limitations to confidentiality** as required by mandatory reporting and court ordered subpoenas.

4.) **Website Browsing**

When using the Resident Bolde's website or services you may give information. Resident Bolde may ask for and maintain information on its visitors and customers to provide a better, more personal experience. Resident Bolde will never sell or trade any of the information accumulated through the course of business about web visitors, clients or other contacts.

Cookies

Resident Bolde's site employs cookies to recognize a return visitor as a unique user. Cookies are small text files placed in the 'Cookies' folder on a visitor's hard disk and allow for Resident Bolde site to

remember the visitor. All web-browsers offer the option to refuse any cookie, and if a visitor refuses the Resident Bolde cookie then browsing Resident Bolde web pages does not gather any information on that visitor.

Information Gathered

Resident Bolde system may gather information such as what kind of browser a visitor is on, what operating system they are using, their IP address, and their clickstream information (for example, which pages they have viewed and how long they have been there). Note that information is only gathered while the visitor is browsing through Resident Bolde website. This information will be used for analytics and marketing purposes to reach potential donors, sponsors and medical residents in training.

Usages of Info

Resident Bolde may automatically receive and record information from website host server from your browser including your IP address, cookie information, time stamp (time page accessed as well as time spent per web page), as well as the specific pages you requested.

The only time Resident Bolde, its partners, subsidiaries, agents, directors, officers or employees would provide specific information to anyone is if required to do so by law, and even then only to the proper authorities.
